Background

Registered voter CHRISTINA ANN COLEMAN, 3/27/1962, is registered with a residence address of 5815 Lacey Blvd SE in Lacey, WA and a status of Active. There is a mailing address on file for this voter in the Voter Registration Database (VRDB) of PO Box 8804 in Lacey, WA.

Previous History

The Washington Voter Research Project originally canvassed this address on September 28, 2021. At the time, the canvasser noted that this location is the Lacey Post Office, a nonresidential address.

On February 7, 2022 I emailed to the Thurston County Auditor's Office a list of 1,927 voters that no longer lived at their registered residence address. COLEMAN was on this list. However, COLEMAN's voter registration is unchanged, and COLEMAN continued to vote from this nonresidential address, most recently on 11/8/22.

Affidavit

On April 26, 2023 affiant Aaron Robinson, postal manager at 5815 Lacey Blvd SE, signed an affidavit declaring that registered voter CHRISTINA A COLEMAN does not reside at that address.

Letter

On May 4, 2023 I mailed a letter via USPS Certified Mail to both addresses on file in the VRDB, notifying the voter that their residence address listed in the voter database is incorrect. The letter encouraged the voter to update their voter registration, provided several different ways the voter could do so, and included an official Washington State Voter Registration Form.

Envelopes

On or about May 21, 2023 the letter to the residence address in the VRDB was returned to me marked "No Such Number – Unable to Forward". On or about May 25, 2023 the letter to the mailing address in the VRDB was returned to me marked "Unclaimed – Unable to Forward".

An Assessor Parcel Search conducted on 4/28/23 shows that there is no real property in Thurston County owned by CHRISTINA COLEMAN. A record exists for a property owned by COLEMAN PROPERTIES WALLC, however a search of the Washington Secretary of State Corporations Database shows that CHRISTINA COLEMAN is not listed as a governing person for COLEMAN PROPERTIES, LLC.

Source 4: Washington Voter Registration Database Extract

The Washington State Voter Registration Database Extract, obtained from the Washington Secretary of State on 6/12/23, shows no other registered voters in WA state with the name CHRISTINA COLEMAN and birthdate of 3/27/1962. There are no registered voters in WA state with the last name of HULLINGS.

The VoteRef website, containing the voter registration databases of at least 30 states, shows no other voters registered with the name CHRISTINA A COLEMAN or CHRISTINA ANN COLEMAN having a birthdate of 3/27/1962. VoteRef also has no record of a voter registration for CHRISTINA HULLINGS.

As of 6/17/23, the Washington Department of Corrections search shows no current incarceration for anyone named CHRISTINA COLEMAN or CHRISTINA HULLINGS.

As of 6/17/23, the Federal Bureau of Prisons Inmate Locator shows a federal incarceration record for CHRISTINA COLEMAN, but the age is inconsistent with the date of birth of 3/27/1962 and the inmate was released on 7/16/2009. No federal incarceration is listed for CHRISTINA HULLINGS.

Conclusion

An affidavit was obtained attesting that CHRISTINA ANN COLEMAN does not currently reside at 5815 Lacey Blvd SE in Lacey, WA, which is a nonresidential address. The data indicates that the voter does not own property in Thurston County, is not registered to vote from another address in Washington state, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter to the residence address was returned marked "No Such Number – Unable to Forward". The letter to the mailing address listed in the VRDB was returned marked "Unclaimed – Unable to Forward". A potential new address of 5043 Foothills Rd, Apt C in Lake Oswego, OR was found in online databases. It is possible that COLEMAN now goes by the last name HULLINGS.

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810.
