11929126 – HONGSEN ZHAO: Voter Challenge Summary

Background

Registered voter HONGSEN ZHAO, 3/13/2000, is registered with a residence address of 6433 Hawks Prairie Rd NE and a status of Inactive. There is no separate mailing address on file for this voter in the Voter Registration Database (VRDB).

Previous History

On December 19, 2022 myself and two other examiners looked at physical ballot envelopes from the November 2020 presidential election as part of a public disclosure request that I had filed. The examination took place in the warehouse at the Ballot Processing Center. Box 29 contained various ballot envelopes that had been returned undeliverable. One of the envelopes in Box 29 had been mailed to HONGSEN ZHAO, with Voter ID 11929126 and Ballot ID 90190630. This envelope had been returned with handwriting that stated, "Not eligible to vote. Only has a temp green card student at PLU."

Affidavit

On April 26, 2023 affiant Bill Blake, at 6433 Hawks Prairie Rd NE, signed an affidavit declaring that registered voter HONGSEN ZHAO "has a green card at PLU (A senior)". The affiant orally stated to the canvasser that ZHAO is not a US Citizen.

Washington Voter Registration Database Extract

The Washington State Voter Registration Database Extract, obtained from the Washington Secretary of State on 6/12/23, shows HONGSEN ZHAO is currently registered with a status of Inactive and an original registration date of 5/2/2018. The "LastVoted" column is null, indicating that ZHAO has not voted in any recent elections.
