- Provides needs assessments, referrals to community resources, monitoring in the community, and case management services to justice-involved individuals with behavioral health disorders.



- Serves individuals on probation with a diagnosed mental health or substance use disorder to promote stronger connections to treatment and recovery support services.




### INTENSIVE SUPERVISION PROBATION COUNSELOR





- Internal resource/support during absences.
- Resources to expand services; limited by what we have available
- The current "view" of probation services Probation is changing!

### **EQUITY**

- Data reporting advancements and future development.
- Partnering with Administrative Office of the Courts and WA State Center for Court Research in developing measures.

#### WHAT ELSE?

- Participant numbers have continued to remain at or slightly above cap through pandemic.
- Current supporting staff is not dedicated to program; having dedicated support staff allows for growth and progression towards program goals.

- Administered by Public Defense
- Provides support to justice-involved individuals with behavioral health needs by assessing needs, making referrals, coordinating services and connecting to resources.





# PARADISE FOUND

 Hire second social worker to allow for a social worker supervisor role focusing more on continuing to develop partnerships, processes, policy, and attend stakeholder meetings.



## WIND IN YOUR SAILS

Relationship with community partners (MH court/MHSA), communication, steady case load growth, building rapport with clients, successful exits.

# **TANCHORS & ROCKS**

 Lack of support for high-risk/high-need clients; continue to reoffend and don't get enough time in the community to make necessary connections. Causes carry-over and impact treatment engagement numbers.

### **EQUITY**

 Continue to provide individualized, culturally appropriate, and excellent care to all clients equally.

#### **WHAT ELSE?**

 Maria Gallo's last day with the County will be June 1<sup>st</sup> and we are in the process of finding a new social services specialist.

### **VETERANS CASE MANAGER**





- Administered by Thurston County Public Health and Social Services
- The Veterans Case Manager connects veterans who have mental health and/or substance use disorders and are in local jails or enrolled Thurston County Treatment Courts with treatment activities, supports, benefits, and services.
