Background

Registered voter DEBRA A PAPE, 5/3/1961, is registered with a residence address of 21726 Oregon Trail Rd SW in Centralia, WA and a status of Active. There is no separate mailing address on file for this voter in the Voter Registration Database (VRDB).

Previous History

According to the USPS NCOA database, a change of address was filed in **April 2021** for DEBRA PAPE to a new address of 140 Uwapo Rd Apt 55-101, Kihei HI 96753.

Affidavit

On June 13, 2023 a resident at 21726 Oregon Trail Rd SW signed an affidavit declaring that registered voter DEBRAA PAPE does not reside at that address.

Letter

On July 7, 2023 a letter was sent to the voter via USPS Certified Mail to the address on file in the VRDB, notifying the voter that their residence address listed in the voter database is incorrect. The letter encouraged the voter to update their voter registration, provided several different ways the voter could do so, and included an official Washington State Voter Registration Form.

Envelope

On August 1, 2023 the letter to the address on file was returned to me as UNCLAIMED UNABLE TO FORWARD.

Data obtained from this source on 8/14/23 shows DEBRAA PAPE, with an age consistent with the birthdate listed in the VRDB, at the address of 1450 S Kihei Rd, Apt A103 in Kihei, HI 96753. This source also states that PAPE is also known as DEBRAA FLAMMANG and DEBRA TOWNSEND.

Source 3: Thurston County Assessor Parcel Search https://tcproperty.co.thurston.wa.us/propsql/front.asp

An Assessor Parcel Search conducted on 8/15/23 shows that DEBRA PAPE does not own real property in Thurston County. Four business entities are listed in the search results, for companies named Pape Machinery Inc, Pape Material Handling Inc, Pape Properties Inc, etc. Subsequent searches of the WA SOS corporations portal and the WA DOR business licensing system revealed that DEBRA PAPE is not listed as an owner, agent, or governing person of any of these entities. Subsequent searches yielded no matches for DEBRA FLAMMANG or DEBRA TOWNSEND.

The Owner History tab on the record for 21726 Oregon Trail Rd SW shows that Jeffrey R Pape and DEBRAA PAPE sold this property to Austin Davis on 3/23/2021.

Source 4: Washington Voter Registration Database Extract

The Washington State Voter Registration Database Extract, obtained from the Washington Secretary of State on 8/3/23, shows no other registered voters in WA state with the name DEBRA A PAPE or DEBRA FLAMMANG in Washington. There is a voter registered as Debra A Townsend, but the year of birth does not match. The data also shows that the challenged voter last voted in November 2020.

Source 5: VoteRef

https://voteref.com/

The VoteRef website, containing the voter registration databases of at least 30 states, shows no other voters registered with the name DEBRA PAPE, DEBRA FLAMMANG, or DEBRA A TOWNSEND with a matching birthdate of 5/3/61. There is a Debra A Townsend born in 1961 registered in South Carolina, but with a different month and day of birth. VoteRef does not contain voter records from Hawaii, and I was unable to locate a publicly available search portal for Hawaii voter registration records.

Source 6: Thurston County Corrections Facility Roster

As of 8/17/23, the Thurston County Corrections Facility Roster search shows no current inmates with the name of PAPE, FLAMMANG, or TOWNSEND.

As of 8/17/23, the Washington Department of Corrections search shows no current incarceration for DEBRA PAPE, DEBRA FLAMMANG, or DEBRA TOWNSEND.

Source 8: Federal Bureau of Prisons

As of 8/17/23, the Federal Bureau of Prisons Inmate Locator shows no incarceration on record for DEBRA PAPE or DEBRA FLAMMANG. Incarceration records were found for Debra Ann Townsend, but the age is inconsistent with the challenged voter and the inmate was released in 1999.

Conclusion

An affidavit was obtained from a resident attesting that DEBRAAPAPE does not currently reside at 21726 Oregon Trail Rd SW in Centralia, WA. The data indicates that the voter does not own property in Thurston County, is not registered to vote from another address in Washington state, and is not registered to vote in the 30+ states covered by VoteRef. The Thurston County Assessors office shows that PAPE sold the property at 21726 Oregon Trail Rd SW in March 2021. The USPS NCOA database indicates that the voter changed address to 140 Uwapo Rd Apt 55-101, Kihei HI 96753 in April 2021. The letter to the voter at the address listed in the VRDB was returned marked UNCLAIMED UNABLE TO FORWARD. Online database searches revealed a possible address of 1450 S Kihei Rd, Apt A103 in Kihei, HI 96753 and that DEBRA PAPE may also go by the names DEBRA FLAMMANG and/or DEBRA TOWNSEND.

This voter meets the requirements for a successful voter challenge.
