Message from Thurston County Auditor Mary Hall



Dear Voters,

We have many important races to vote on this election! Be sure to have your ballot returned by November 7, 2023.

Not only do we have leaders of our cities and school districts on our ballot, but we are also voting for two new county and port commissioners. Overall, we'll be electing almost 80 officials who will serve in your own backyard.

These county commissioners, mayors, city council members, port commissioners, fire commissioners, and school board members will make important decisions on your behalf. Issues that you care about, such as access to housing, homelessness, environmental protection, and education, are all influenced by the people on this year's ballot.

We'll also be electing two new county and port commissioners. Last year, voters approved expanding both of those boards from three to five commissioners. The commissioners of these two new districts will be elected this year.

This Voters' Pamphlet contains information on local elected offices, what each office does, and information submitted by the candidates themselves. It provides an opportunity to get to know the candidates.

Our election system in Washington State is as close as you can get to a perfect balance between access to voting and the security of elections.

I value the security of our Vote-by-Mail environment and the strong rules and laws that govern our elections in Washington State. We check the signature on the oath of every ballot return envelope, so we know each ballot we count was filled out by the intended voter. Our signature checkers are trained by the Office of the Secretary of State.

We also conduct several pre- and post-election audits to ensure your ballot is counted properly. These audits are open to the public. If you want to attend, look for more information at ThurstonWAVotes.gov or contact the elections office using the contact information below.

After you have returned your ballot, you can track it to be sure it will be counted by visiting VoteWA.gov. Simply enter your name and birthdate and click on the ballot status, which is updated daily.

Remember, you can register to vote up to 8:00 pm on Election Day. If you have any questions about our election process, please don't hesitate to contact my office at 360.786.5408 or elections@co.thurston.wa.us.



Position Descriptions

County Commissioners: Serves as the local government and legislative authority outside city limits.

Port of Olympia Commissioners: Set economic objectives, policies and overall Port direction through comprehensive plans.

City & Town Councils: Thurston County has two types of government: council-manager or mayor-council. Under both, the council is the legislative and policy making body.

Council-Manager (Lacey): The city council appoints a city manager to oversee day-to-day affairs and selects one member to act as chair, with the title of mayor, presiding over council meetings and serving as ceremonial head of the city.

Council-Manager (Olympia): The mayor is elected, presides over council meetings and serves as ceremonial head of the city.

Mayor-Council (Bucoda, Rainier, Tenino, Tumwater and Yelm): The mayor and council members are elected. The mayor administers day-to-day city affairs, presides over council meetings, and has veto power.

School District Directors: Five directors make a board whose responsibilities include: budget, policy development, curriculum approval, planning and communications for the school district.

Fire Protection District & Regional Fire Authority Commissioners: Commissioners oversee districts that provide fire prevention services, fire suppression, emergency medical services and the protection of life and property in the county. With voter approval, they may issue bonds and make excess levies for specific purposes.

Parks and Recreation District Commissioners: State law allows for the formation of park and recreation districts as municipal corporations for the purpose of providing recreational activities of a non-profit nature as a public service to the residents of the district. These districts may acquire property, make contracts, establish fees, make rules governing park property, and manage and operate facilities. They may also impose property taxes, establish local improvement districts, and issue revenue bonds.


Cemetery District Commissioners: Commissioners acquire, improve and operate cemeteries. They also set a budget and establish fees and rules for cemetery use.

Drop boxes are securely locked and emptied by teams of two trained elections officials. Boxes are open 24/7 beginning October 18 and close promptly at 8 p.m. on November 7, Election Day.

- 1. Late postmarks can't be accepted. If it's Election Day and you haven't mailed your ballot, put it in one of our 30 drop boxes!
- **2.** Return your **entire ballot packet**, especially the return envelope that you sign. If you only return the security sleeve, we have no signed declaration and it won't get counted.
- **3.** Be sure to **sign your voter's declaration**. If you don't sign, we will send you a cure form. If you don't return it, we can't count your ballot.
- **4.** Make note of how you signed when you registered and sign that way on your return envelope. This is what we use to verify your signature. If your signature has changed, contact us. **Don't sign someone else's voter declaration** or have anyone else sign for you, even a family member. We will challenge the signature. If we challenge your signature, we send a cure form asking you to sign a voter's declaration and return it to us. If the letter matches the signature on the return envelope, we can count it.
- **5.** Power of attorney cannot be used to sign someone else's ballot. If you can't sign, **make any mark** on the signature line and **have two witnesses sign.**

Thurston County Proposition No. 1

Sales and Use Tax for Law Enforcement Protection, Corresponding Prosecution and Public Defense Services, and Elections Security

The Thurston County Board of County Commissioners has adopted Resolution No. 16289 concerning imposition of a sales and use tax pursuant to RCW 82.14.450. If approved, this proposition would authorize an additional sale and use tax at a rate of two-tenths of one percent to be used, of the County distribution, for up to 75% in law enforcement protection, including hiring additional sheriff deputies, and associated infrastructure, and up to 25% for additional prosecution and proportionate public defense services, and elections security infrastructure as stated in Resolution No. 16289.

Explanatory Statement

Proposition 1 authorizes the County to raise funds for public safety purposes through an increase in the sales and use tax as set forth in RCW 82.14.450. This measure will impose a sales and use tax in the amount of two-tenths of one percent. All revenues shall be distributed as follows: 60% shall be retained by Thurston County and 40% shall be distributed on a per capita basis to cities within Thurston County.

The county plans to use its share of this funding exclusively for hiring additional sheriff deputies, supporting law enforcement services and associated infrastructure, including facilities, (75%), and additional prosecution and public defense, and elections security infrastructure, including facilities (25%). This funding cannot be used to supplant funding for any ongoing services and/or programs.

The proposed increase in the sales and use tax will continue to produce revenues for these public safety purposes in future years.

Argument For

Invest in Public Safety

Our community is safe when our law enforcement agencies are fully staffed. That's why we need to invest in more law enforcement officers and mental health co-responders. With more deputies and mental health professionals on the streets, we can respond to crimes faster and keep our neighborhoods and families safe.

Urgent action is required. Right now, Thurston County ranks 38th out of 39 counties in deputies per capita. *That's not good enough.* We need to boost our law enforcement numbers so we can effectively combat crime and protect our community. Argument Against

Would you pay \$10 to get \$4 of service? Vote No! Under state law for Public Safety Sales Tax, only 60% of the revenue goes to the county, the other 40% goes to the cities. Of the total tax collected less than 40% will be directed to actual law enforcement for the county. Vote No!

The planned and budgeted absence of a proper level of funding for road deputies, is now being presented as a "lack of funding" to manipulate the voters to support more sales tax increases. Do you trust that your current tax dollars are being spent effectively for the primary required services by Thurston County? No! Should the city taxpayers supplement the unincorporated for additional law enforcement in addition to paying to provide their own law enforcement? No!

Does "more sheriff deputies on the road" mean that the proposed tax should be used to build election facilities? No! Did the county need a second assistant county manager? No!
