Action: Tom presented on the handouts and opened the discussion on whether and when the group preferred to issue a Request for Information (RFI) to place affordable housing projects on the Housing Capital Pipeline for future years' funding. The RFI has historically been used to solicit projects to be placed in the Housing Capital Pipeline three years from the date the RFI is issued. The projects are then expected to reply to the Request for Proposals issued in the given year corresponding with their pipeline placement to confirm they are ready to proceed. The process allows projects in the pipeline to communicate a soft commitment of funds from the County to other prospective funders. The County last issued the RFI in 2021 for 2024 pipeline projects.

The group decided to issue an RFI in February 2024 to solicit projects to be placed in the pipeline for 2025. Using the RFI to potentially identify 2026 pipeline projects was also discussed.
