### 777602 - NICOLE KELLY: Voter Challenge Summary

### **Background**

Registered voter NICOLE KELLY, 3/20/1974, is registered with a residence address of 3832 Golden Eagle Loop SE in Olympia, WA and a status of Active. There is a separate mailing address on file for this voter in the Voter Registration Database (VRDB) of 1931 69<sup>th</sup> St SE, Auburn, WA 98092.

### **Previous History**

According to the USPS NCOA database, a change of address was filed in June 2019 for NICOLE KELLY.

The Washington Voter Research Project originally canvassed this address on December 2, 2021. At that time the resident stated to the canvasser, "We moved in July 2019, she was the former owner."

On February 7, 2022 I emailed to the Thurston County Auditor's Office a list of 1,927 voters that no longer lived at their registered residence address. KELLY was on this list. However, KELLY's voter registration is unchanged.

### **Affidavit**

On April 26, 2023 a resident at 3832 Golden Eagle Loop SE in Olympia, WA signed an affidavit declaring that registered voter NICOLE KELLY does not reside at that address.

#### Letter

On May 4, 2023 letters were sent to the voter via USPS Certified Mail to both addresses on file in the VRDB, notifying the voter that their residence address listed in the voter database is incorrect. The letter encouraged the voter to update their voter registration, provided several different ways the voter could do so, and included an official Washington State Voter Registration Form.

### **Envelope**

On May 20, 2023 the letter to the residence address on file was returned to me marked RETURN TO SENDER UNDELIVERABLE AS ADDRESSED UNABLE TO FORWARD. USPS tracking information indicates that the letter sent to the mailing address on file of 1931 69<sup>th</sup> St SE, Auburn, WA 98092 was delivered on May 6, 2023. However, the voter has not updated their voter registration.

An Assessor Parcel Search conducted on 9/21/23 shows that NICOLE KELLY does not own real property in Thurston County. Further research of the property at 3832 Golden Eagle Loop SE in Olympia, WA indicates that NICOLE KELLY sold this property in July 2019.

### **Source 4: Washington Voter Registration Database Extract**

The Washington State Voter Registration Database Extract, obtained from the Washington Secretary of State on 9/5/23, shows no other registered voters in WA state with the name NICOLE KELLY having a birthdate in 1974. The data indicates that KELLY last voted in November 2022.

### Source 5: VoteRef <a href="https://voteref.com/">https://voteref.com/</a>

On 9/21/23 I searched this voter's name on the VoteRef website, which contains the voter registration records of 30+ states. Due to recent changes in the configuration of the VoteRef website, it is difficult to extract data from this site. The nationwide search is not functioning property, and returned an improbable result of over 300,000 potential matches for this voter.

In order to fulfill the requirement in RCW 29A.08.010(1)(c)(ii)(E) to search "the voter registration database of another state", I narrowed the search to the adjacent states of Idaho and Oregon. The only potential match with the same year of birth is a voter named Nicole L Kelly at 852 W Williams St in Boise, ID.

As of 9/21/23, the Federal Bureau of Prisons Inmate Locator shows no incarceration on record for NICOLE KELLY.

#### Conclusion

An affidavit was obtained from a resident attesting that NICOLE KELLY does not currently reside at 3832 Golden Eagle Loop SE in Olympia, WA The data indicates that the voter does not own property in Thurston County, is not registered to vote from another address in Washington state, and is not registered to vote in an adjacent state. The voter filed a change of address with the USPS in June 2019, and sold the property at 3832 Golden Eagle Loop SE in July 2019. The letter to the voter at the residence addresses listed in the VRDB was returned marked RETURN TO SENDER UNDELIVERABLE AS ADDRESSED UNABLE TO FORWARD. The letter to the mailing address was delivered, but the voter has not updated their registration. Online database searches indicate an address of 1931 69th St SE, Auburn, WA 98092.

This voter meets the requirements for a successful voter challenge.
