Request: The Applicant requests approval of a Reasonable Use Exception (RUE) to construct an 1,872 sq ft single-family residence, 7,018 sq ft driveway, well, septic, and drainfield on a 1.79 acre parcel. The parcel is encumbered by a Category III wetland, which has a standard buffer of 260 ft. A RUE is required to reduce the wetland buffer to 195 ft, beyond what is allowed in code. An on-site Type F stream is also on the property and has a 150 ft buffer that cannot be reduced.
