In drafting the staff report, I'm not seeing that the project ever responded to the last several of my ongoing comments highlighted in the attached Matrix (Round 4) that was sent to you on (10/27/22). I believe the project stated some time ago that you would like to move forward to hearing as-is. It would greatly benefit the project if you could address these items and provide them to me in the next week so that I can include them in the staff report. I will otherwise have no choice but to state that these items weren't provided though there is record that they were asked for more than once and beginning months ago.

Item 7, for example, could stop your project from moving forward at Hearing. As stated in the Matrix, you must prove that each lot can achieve the 60% maximum impervious surface coverage <u>prior to approval</u>. This is significant. Item 5.w. is significant enough to do the same, as well.

Please get these items to me by 4/13 at the latest.
