Sharron,

Your obviously not concerned with meeting your municipally mandated timeframe for processing projects inline with the code. I'm going to talk with my client to see if we need to elevate this to get legal involved. We do not care if your understaffed or unqualified to do the work. The county has committed to meeting a 120 day timeframe for this process in municipal code. Code does not mention exceptions for understaffing. You have a binary recommendation to make if the project meets code or does not. In this scenario you are not even qualified to make a decision on the approval but rather make recommendation to a hearings examiner.

I was ready to go in-front of the hearings examiner on day 120 from complete application. If the county cannot produce a recommendation in line with municipal code then that is fine. I assume the project is fully approved as submitted as the county staff has failed to comment in the time period required.
