## **#2 - Racial Equity Action Plan Approved by Thurston County**



On Tuesday, November 28, the Thurston County Board of County Commissioners approved the Racial Equity Action Plan. The Racial Equity Action Plan has been in the works for two years, beginning when the county declared racism a crisis, along with the Board of Health proclaiming racism as a health crisis in Thurston County. Both were adopted on March 9, 2021, through Resolution No. 15995. The plan has five phases, with the county currently in Phase 1, Diagnosis. Phase 1 involves acknowledging current practices and policies do not serve the intersectionality of our community and the county will work to identify barriers and build trust between government and community members to effectively make change.

Multiple members from the Racial Equity Council and Thurston County's League of Women Voters were present at the November 28 presentation. They spoke passionately about the importance of the plan and the council's work bringing the plan to fruition.

# BEST WAYS TO PROTECT YOURSELF FROM COVID-19, INFLUENZA, OR RSV



- Get all the vaccines recommended for you
- Get tested if you have symptoms of COVID-19
- Consider masking indoors when respiratory virus levels are high and if you are at high risk of severe disease or are in close contact with people at high risk of severe disease
- Wash your hands often
- Cover coughs and sneezes
- Clean and disinfect high touch surfaces

It is common to get sick from respiratory viruses such as COVID-19, flu, and respiratory syncytial virus (RSV), especially in the fall and winter. There are actions you can take to protect yourself and others that include:

- Get all the vaccines recommended for you
- Get tested if you have symptoms of COVID-19
- Consider masking indoors when respiratory virus levels are high and if you are at high risk of severe disease or are in close contact with people at high risk of severe disease
- Wash your hands often
- Cover coughs and sneezes
- Clean and disinfect high touch surfaces
