Ms. Cady,

It looks good. The only comment I have relates to item B. L. It says their current asphalt pile meets storage standards because it is currently covered by tarps. Best Management Practices state that there should be an air space between the (roof) cover and the material, This allows the recycled asphalt to dry if it contains moisture. It also allows the plant to produce asphalt at a lower temperature by not having to drive the moisture out of the RAP. This benefits those producing the asphalt by using less fuel and reduces air pollution for those near the plant. I quoted that in my past comments.

Lakeside has been a good neighbor and their modern plant is now positioned to be even more state-of-the-art. By the way, years ago, I saw Lakeside had the same kind of RAP covering structure at a smaller plant near Aberdeen.

Ms. Cady,

I was able to sit in on yesterday's Zoom meeting and hope I will be on the list to receive the documents that will be sent to interested parties for a two week evaluation. I have been involved in this issue for over 15 years and was the one that suggested modifying Goal E.5 of the 1992 Nisqually Sub-Area Plan as a compromise that would benefit Lakeside by allowing RAP. This change will prevent RAP leaching into the ground water under the mine's permeable soil in this "Wellhead Protection Area" neighborhood. RAP will be stored under a weather protected roof cover with an air space under it.

Holroyd's Pit, where Lakeside resides, is close to being mined out. Goal E. 5 still says the pit must be reclaimed when that happens. So, there will likely be pushes for more changes in the future. Holroyd's Pit has been pushing for the last several years to change their license to allow mining eighty feet into the aquifer below the pit. This should not happen. Accessory Uses currently are prohibited by Goal E.5 from importing more than 50% of needed mineral resources into the pit. So, there are likely more changes to come in the not-to-distant future, These changes must be done carefully in this sensitive area.

If the above comment fits what might come back from the two week evaluation of this issue, feel free to use it.
