Thank you for the opportunity to respond to this comment. Lakeside's response is as follows:

Mr. Glastetter's comment refers to B.I. of the Staff Report, which identifies the Nisqually Subarea Plan's requirement to cover recycled asphalt pavement (RAP) in the subarea. As the County noted in its Staff Report, this standard is currently met by the tarping that Lakeside installed on site. Lakeside agrees with the County that the existing tarp satisfies this requirement.

Nevertheless, Lakeside's project would address Mr. Glastetter's comment, because the proposed 15,383 square foot cover structure would create air space between the cover and the RAP.
