CALL TO ORDER/ROLL CALL – Chair VanCamp called the meeting to order at 2:00.

- II. APPROVAL OF AGENDA MSC (Hurley/Curtis) move to approve the agenda and this carried.
- III. PUBLIC PARTICIPATION None

IV. REVIEW AND APPROVAL OF MINUTES

- 1. Operations Committee October 5, 2023 (Brooks/Hurley) move to approve the minutes and this carried.
- 2. EMS Council No October meeting (Informational only)

V. COMMITTEE REPORTS

A. West Region EMS Council – Clem reported: 1) The council has not met since the last Ops meeting. The next meeting is December 6th by zoom only. There is discussion about possibly moving to a hybrid format in 2024. 2) The Training Education Committee (TED) is continuing to plan the conference, which is May 17 – 19, 2024. Medic One will be doing a skills session with our new Point of Care ultrasound devices.

B. Subcommittees

- Equipment Committee (EqC) Rian Winter reported: 1) Drug shortages include: D50, 250 cc sapine bottles, lidocaine, ketamine, albuterol and sodium bicarbonate. 2) Video laryngoscope is in finance, no changes. 3) Sterile gloves are available for central line placement. 4) POCUS probe covers are being ordered. Kits are going to be put together for POCUS IV and central line starts. 5) New BVM rollout program is in process before trial starts. 6) Next meeting is November 15th at 0930.
- 2. Mass Casualty Incident (MCI) Committee No meeting, no report. Next meeting is November 29th at 1000.
- 3. <u>Training Advisory Committee (TAC)</u> No meeting since the last Ops meeting.
- 4. <u>Transportation Resource Utilization Committee (TRU) / Hospital Diversion</u> Brooks reported: Continuing to get updates from the hospitals and private ambulance providers. Still working through the notification process for ambulance levels, and the Ops Chiefs are still looking at the best way to share that information. Clem said the stand-alone ED folks have been invited to the next TRU meeting, as well as NW Ambulance, to talk about transport plans from the ED facilities.
- 5. ePCR Committee Clem reported: The ePCR meeting has been combined with the BLS MSO meetings.
- C. Staff Report Staff report is located on the website at https://www.thurstoncountywa.gov/m1/Pages/meetings.aspx

VI. OLD BUSINESS

- A. <u>EMSC Report</u> No October meeting to report on.
- B. <u>EMT Course Workgroup Charter</u> Clem reported: The first meeting is scheduled for November 9th, and he will send out materials later today or tomorrow. Recommendation was planned for December; however, this has been moved to the January Ops meeting.
- C. <u>TCMO Medical Protocols</u> Clem presented some of the changes and new features that have been made to the protocol document, which has been submitted to DOH. April 1, 2024 is the estimated effective date.

- D. <u>TCMO 2024-2025 Budget Process</u> Miller-Todd reported: Budget deliberations were last week and preliminarily everything that was recommended by the EMSC has been approved; however, public comments will be heard on December 5th, so a tentative approval date is December 12th.
- E. <u>EMSC Comprehensive Plan</u> Clem reported: Various stakeholders have presented to the Comprehensive Plan Committee. Olympic Ambulance will present at the meeting following Ops today, and South Sound Behavioral Hospital is scheduled to present at a future meeting. The stakeholder presentations will be incorporated in the comprehensive plan document.

VII. NEW BUSINESS

- A. <u>2024 Ambulance Applications</u> (Brooks/Keogh) move to recommend the 2024 ambulance applications for Olympic Ambulance and AMR to the EMSC, and this carried. NW Ambulance is applying for an ambulance license, as they will be the transport unit for the stand-alone ED. If they are unable to receive a license, then Olympic Ambulance will be the transport unit.
- VIII. GOOD OF THE ORDER Chair VanCamp asked the committee about cancelling the December meeting if there are no critical discussions or actions. Miller-Todd said we have a pending issue with an opening OCED that is going to happen in the middle of December, and we are still trying to find out what is going to happen with response to that facility. A cancellation notice will go out to the committee if it turns out that December will be cancelled.

CALL TO ORDER/ROLL CALL – Chair Moon called the meeting of the Emergency Medical Services Council (EMSC) to order at 3:30 PM.

- I. APPROVAL OF AGENDA MSC (Carroll/Greenstein) move to approve the agenda and this carried.
- II. PUBLIC PARTICIPATION None.

III. REVIEW AND APPROVAL OF MINUTES

- A. EMS COUNCIL September 20, 2023 (Kirkbride/McPhee) move to approve the minutes, and this carried.
- B. OPERATIONS COMMITTEE October 5, 2023, November 2, 2023 (informational only)

IV. COMMITTEE REPORTS

- A. **OPERATIONS COMMITTEE:** Miller-Todd reported: 2024 ambulance applications for AMR and Olympic, were reviewed and approved and are on today's EMSC agenda for recommendation to the BoCC.
- B. WEST REGION EMS COUNCIL: No report next meeting is December 6th.
- C. STAFF REPORT: Staff report is available on the website. Thurston County | Medic One | Committee Meeting Information (thurstoncountywa.gov). Miller-Todd highlighted on the following: 1) An offer letter has been signed for the Paramedic Program Manager position. His name is Juan Mejias, he is from Texas, and is scheduled to start work on January 2, 2024. 2) Paramedic testing did not pass any candidates. Working on engaging more with JBLM for candidates. 3) A calendar invite will go out for the EMT graduation which is scheduled to take place December 18th.

V. OLD BUSINESS

A. 2024-2025 Budget Update – Miller-Todd reported: Everything recommended by the EMS council has been preliminarily approved by the BoCC. The BoCC was forced to consider an 8% reduction in the general fund, which would have been a reduction of roughly \$174,000 from the Emergency Management budget, and this would have entirely come out of FTEs. After deliberations, the BoCC was able to identify a couple of different funding sources which helped reduce the budget cut for Emergency Management to \$6,000. A large portion of the reduction was from the rising of costs, and a reduction in sales tax revenue. Sales tax had radically flattened from a 7 or 8% growth to roughly 2-3% growth projection. The county is able to get through the 2024-2025 biennium, but the conversation isn't going to stop – looks like it will carry over to the 2026-2027 budget. As far as the Medic One budget, our levy rate is not as high as it could be, so if the underlying assessed value shrinks, we still have the ability to grow to 7% year after year and not hit the \$0.50 cap.

Back in September the BoCC approved \$1.6 million in ARPA (American Rescue Plan Act) funding for 4 of the 8 medic units we were procuring this year and next year.

VI. NEW BUSINESS

- A. <u>2024 Ambulance License Applications</u> (Hambly/McPhee) move to approve recommendation of the 2024 ambulance applications for AMR and Olympic, to the BoCC, and this carried.
- B. <u>MultiCare OCED Interfacility Transports</u> Northwest Ambulance is the contracted provider for the MultiCare off campus ED (OCED), and Olympic Ambulance is the backup provider. Northwest has submitted their application to DOH for a BLS verified licensure, and if DOH approves then it will go to WREMS, and WREMS will pass it on to the EMSC for operational review (there is an open position in our min/max). To our knowledge, WREMS has not seen the application.
- C. <u>Healthcare System Update</u> MultiCare OCED is scheduled to open mid-December. Staff is working closely with them regarding protocols and operational components. Miller-Todd said MultiCare CMC (main campus) is doing similar processes as St. Peters to try and clear out beds, and they have done well at meeting their goals.
- D. Medic One 3rd Qtr. YTD Expenditures Keene reported: Overall, Medic One has expended 55% of their budget through September 2023. Salary expense is low due to vacant positions. A large portion of savings has to do with the ER&R (medic units). Admin is 65% expended overall, ALS is 59%, BLS is 64%, IT is 54% and ER & R is 0%. We will see expenses in ER&R later this month for the new MA1 vehicle, AEDs, and radios. 4th quarter financials close out in March of 2024. Keene also mentioned that the State Auditor's are here in November, and they selected Medic One for medic unit procurement, credit card charges (we heavily use the credit card and receive substantial rebates for the usage), and revenue received, which we really don't receive much.

- VIII. GOOD OF THE ORDER Kirkbride said the Comp Plan Committee has met with MultiCare, Providence St. Peter, Olympic Ambulance, and is meeting with South Sound Behavioral hospital today. Kirkbride said there will be an update after the first of the year.

Northwest Ambulance CCT - BLS Trauma Verification License Application
Supplemental question response:

a. Consistency with the approved regional plan and patient care procedure.

Northwest Ambulance (NWA) shall follow Thurston County EMS Protocols as well as adhering to Washington State Department of Health patient care standards. NWA operates in 6 different Washington State counties and in each one we have followed the specific county protocol and our medical program directors (MPD) orders of operations. As of date, NWA in 16 years has not received a transport care citation or violation.

b. Vehicles and Equipment.

Each Transport Ambulance shall be certified by the Department of Health as a Licensed Ambulance. The equipment on each unit shall meet or exceed WAC 246-976-300 vehicle equipment standards. Line-staff are required each morning or during shift change to conduct a vehicle maintenance and equipment check, this is to assure our rigs are street legal and fully equipped for medical transports.

c. Sufficient Staffing levels.

Northwest Ambulance has over 300 Employees made up of EMTs, RNs, and Paramedics.

The transport units assigned to Thurston County will be staffed with only EMT's and RN's. The staff level shall be maintained by our "Staffing Division Chief" who will confirm operational levels do not drop below requirements. We are fortunate to have a great staff that, if needed, our personnel can shift response zones to help cover calls. If

we do not have certified Thurston County EMTs or RNs, our directive will be to transfer the incident to another ems company that is certified and cleared to operate in Thurston County.

d. Trauma Training Program

 How the services present certified EMS personnel have been, or will be, trained so they have the necessary understanding of department approved Medical Program Director (MPD) protocols.

Northwest Ambulance has hired a Thurston County Paramedic who will begin providing initial medical training (Bridge Course) on Thurston County protocols. The training program will consist of cognitive and didactic testing to confirm each employee understands and can apply the county protocols. We are currently working with Thurston County Medic One program director and their MPD.

How the service will assure that its personnel understand their obligation to comply with the MPD protocols.

Northwest Ambulance will assure compliance is followed in two ways, the first is EMT's or RNs shall attend monthly QA/QI meetings with our Thurston County Paramedic and NWA MPD Dr. Ryan Keay. Second, we would want our MPD to have an excellent working relationship with Thurston County MPD to ensure we are upholding county ems standards. Finally, we would find it beneficial to integrate our leadership team into Thurston County Medic One committee meetings.

3. How the service will assure that its personnel will maintain currency with the protocols whenever they are revised.

Thurston County has made this easy by providing ems professional access to their protocols through an app on a cell phone. Each unit and crew member operating in Thurston County will access to this app anytime they are working.

4. How the service will address the numbers 1-3 for new personnel as they join the organization.

Northwest Ambulance provides orientation training for all new members and since we now know the expectation set by Thurston County Medic One. This will be implemented on all new hire/s assigned to Thurston County.

5. Participation and compliance with regional quality improvement.

Northwest Ambulance will assign upper-level management to participate or attend Thurston County Medic One meetings as well as West Region EMS council meetings. Again, as stated above we believe a strong partnership with our MPD and Thurston MPD will help us stay in compliance and improve our quality of care.

EMS AGENCY TRUAMA LICENSE VERIFICATION APPLICATION PACKET:

1. Dispatch Plan

Northwest Ambulance (NWA) receives transport/dispatch requests through our 10-digit phone line. The transport requests are processed in our dispatch center using an AI software system called Logis. This computer aided dispatch program selects the closest, and most appropriate unit to handle the transport. Dispatch and crew members communicate using mobile data devices.

When NWA experiences a true 911 Emergency call or transport it is our policy to allow the local fire/EMS agencies to handle. This is done in two ways, the crew will either dial 911 requesting the help that is needed or they will use their emergency radio hailing the dispatch center nearest them to send most appropriate unit/s. It is not our primary practice to handle 911 emergency medical or trauma calls, but to provide non-emergent transport.

2. Response Plan

Northwest Ambulance (NWA) will provide ground ambulance services from our Tacoma HUB facility, 22 minutes away from the Thurston County line. Our main type of transport will be post hospital care or stabilized patients requesting transfer to a higher care facility. Should the request to provide emergency care, then NWA would have to add an addendum to our license and locate a base station to meet WAC 246-976-390 and RCW 18.73 requirements.



3. Response Area

Northwest Ambulance is expected to provide services to MultiCare facilities in Lacey and we anticipate other hospitals will utilize us when needed for immediate transports. We believe our response area will begin north at Interstate Five and the Nisqually River, run through Lacey, Olympia, Tumwater, and end south near Grand Mound.

4. Type of transport

Northwest Ambulance is contracted with MultiCare to provided interfacility transport services. MultiCare is opening a off campus emergency department (OCED) center in Lacey. This license agreement is attended only for this service. We expect the Lacey MultiCare OCED will care for medical and trauma patients. NWA will assist the OCED by transporting those patients to higher level care facilities in and around Thurston County.

5. Tiered response and rendezvous

Northwest Ambulance will not be utilizing a tiered response system or rendezvous. We do not have any EMS or Fire Service contract requiring us to provide additional support or a tiered system.

6. Back-up Plan to Respond

Northwest Ambulance is not anticipating emergency medical services, we will allow the local fire service or agencies handle this. If NWA unit has a need for emergency medical service due to patient deteriorating or unable to provide the best level of care, our policy and procedures requires the transport unit to request the closest available 911 unit.

7. Interagency relations

Northwest Ambulance agrees with the Department of Health that interagency relation is important for achieving optimum efficiency in patient care. NWA desires to participate in local and regional EMS council meetings. We want to actively be part of the emergency medical community that supports each other through MOU's, Mutual Aid Agreements, and by collaboration.

8. "Needs and Distribution of Services"

Northwest Ambulance is not duplicating an EMS agency or asking West Region to adjust their min/max provision. According to state documents, there are 2 Trauma Verification License available. NWA is seeking to obtain one of those licenses so that we can provide transport service for MultiCare in Lacey and potentially for St. Peter's, MultiCare Capital, Kaiser Permanente Olympia, and closely related facilities. We will not compete again with Fire/EMS agencies or attempt to replace their jurisdictional authority.

Our ambulances will be stationed out of Tacoma, thus keeping unnecessary transport units out of Thurston County.

9. How this meets the needs as outlined in the Approved Regional Plan

Northwest Ambulance is providing a non-emergent transport service to facilities, especially the new Lacey, OCED. With our company providing this essential service, the facility, community, and local emergency services will benefit. Facilities can transfer patient sooner, discharge from beds can increase, and in-patient availability will be more readily available. Community members will see less wait times at clinics or emergency departments, more tax dollars are saved by not having local ems agencies out of service providing non-emergent transports. Fire/EMS agencies will be more available for true emergency calls, community outreach, and other essential services.
