Lindsey,

There is apparent misinformation on the notice of hearing. The location cited as the se corner of Sleater Kinney and 26th is nowhere near the legal parcel description that is apparently off Henslin. Michele and I will not be available to attend the hearing on Monday, but would offer some concerns if the hearing is indeed applicable to the parcel near us:

Access to/from Waldon Drive must be by foot travel only unless emergency vehicle access is needed. Waldon Drive is a short road used by local residents only. A thoroughfare with free access between Yelm Highway and 58th via Waldon Drive would dramatically increase the amount and speed of traffic and significantly increase the probability of injury and death to pedestrians (including school children) as well as drivers/passengers. Even under current traffic conditions, there have been several fatalities on or near the corner of Waldon Drive and Yelm Highway.
