RESOLUTION NO. 24-03

of the

SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and the Bylaws of the Squaxin Island Tribe as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, under the constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of the tribal members, and with protecting and managing the lands and treaty resources and rights of the Tribe; and

WHEREAS, the Tribe is a federally-recognized Indian Tribe possessing reserved powers, including the powers of self-government; and

WHEREAS, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; and

WHEREAS, the Thurston County Board of Health has the authority to enact local rules and regulations as are necessary to preserve, promote and improve public health pursuant to RCW 70.05.060; and

WHEREAS, the Thurston County Board of Health has solicited recommendations from the Squaxin Island Tribe for appointments to the Board.

THEREFORE, BE IT RESOLVED, the Squaxin Island Tribal Council does hereby recommend and request the appointment of Ray Peters to the Thurston County Board of Health.

CERTIFICATION
