## #1 - 2024 Property Taxes Mailed to Thurston County Taxpayers



2024 Property Tax notices went out in the mail to Thurston County taxpayers on Friday, February 9, 2024. Property tax amounts can now be viewed and paid through the [Thurston County Treasurer's website](#).

Thurston County's 2024 total property taxes assessed for all jurisdictions is \$580,604,188.

Payment can be made by electronic check on the Treasurer's website with no additional fee. You may also pay by major credit card which has an additional 2.35% transaction fee, or a VISA Debit card that has a flat fee of \$3.95. Thurston County receives none of the transaction fee.

Taxpayers can make property tax payments online, by mail, over the phone, or at the parking lot drop box – located outside our new office location of 3000 Pacific Ave SE, Olympia WA 98501. Payments may also be made in person, but the same transaction fees apply for payments made in person or over the phone.

The Treasurer's Office hours are 8:00 a.m. to 4:30 p.m. Monday through Friday. Payments made by mail must be postmarked by the due date. As required by Washington State law, late fees will be charged for those who do not have their payments in on time.

The Treasurer's Office would like to remind property owners you can sign up to receive property tax bills electronically. This is an opt-in service that requires the taxpayer to create an account.

## **#2 - Commissioners Appoint Leonard Hernandez as County Manager**



After an extensive search, interview, background, and reference check process with both internal and external partners, the Thurston County Commissioners have appointed Leonard Hernandez as the new Thurston County Manager. Hernandez previously served in a similar capacity in San Bernardino, California. He will begin his role as the county manager on Monday, April 1, 2024. His starting salary is \$220,000 with a hiring bonus of \$20,000 and a \$5,000 moving stipend.

Thurston County Commission Chair, Tye Menser said, “we are very excited to welcome Mr. Hernandez as our new county manager. After a lengthy and thorough hiring process, including multiple panels with internal and external stakeholders, Mr. Hernandez was the top candidate. He brings a wealth of experience and fresh ideas which will be of great benefit to the county. We look forward to welcoming and introducing him to our community.”

Hernandez served as Chief Executive Officer for San Bernardino County in California for three years prior to resigning for an urgent family health issue. He has worked in city and county executive leadership roles for more than ten years and was with the San Bernardino County Library system for an additional ten years. Government and library positions included deputy executive officer, interim museum director, county librarian, and head of the Fontana library.

## #3 - Public Comment Sought on Proposed Projects for the 2024 - 2025 Comprehensive Plan and Development Code Dockets



### Thurston County Board of County Commissioners Seeking Public Comment

The Thurston County Board of County Commissioners (BoCC) is seeking public comment on the proposed comprehensive plan amendments and development regulation changes for the 2024-2025 dockets. The Comprehensive Plan docket contains amendments to zoning and/or visionary policies. The Development Code docket contains proposed changes to what you can do with your land and the types of permits you may need.

**The comment period is from February 23 to March 14 by 5:00 p.m.**

Following the comment period, The BoCC will select and prioritize projects for each docket. They will sort projects based on their priorities, staff capacity, and budgetary restraints.

Projects added to the work plan (official dockets) will then be forwarded to the Thurston County Planning Commission for review. The Planning Commission and BoCC will hold public hearings on the merits of the project approved for the official dockets prior to adoption of any final regulations.

The Thurston County Board of County Commissioners (BoCC) is encouraging interested members of the public to apply for one of the 25 citizen advisory boards, commissions, and committees. Community members bring an important point of view, often representing a geographic interest, area of expertise, or professional association. The county is actively recruiting applicants for the Board of Equalization and Civil Service Commission.

The Board of Equalization (BOE) is a quasi-judicial board separate and independent of the Thurston County Assessor's Office. The BOE impartially adjudicates appeals brought by taxpayers on assess property valuations and other determinations of the Assessor. The Civil Service Commission makes decisions on proposed revisions to Civil Service rules, classifications, and employment standards, and hears appeals to eligibility list removals.
