Hello Mr. Grayson,

Thank you for submitting comments on behalf of the Indian Summer Homeowners. If possible, please share this email with others in your community that are interested in the park and school project.

Please see below for the Olympia Parks, Arts, and Recreation and Olympia School District's responses to your comments. Note that we are awaiting comments on our permit submittal from Thurston County. Comments from Community Planning and Economic Development and Public Works may impact the design plans and require changes that we are not yet aware of.

Berm and fence request. The property line between the park and Indian Summer is currently fully fenced. In response to initial concerns from some neighbors along Ashborne regarding a park planned adjacent to their back yards, the design team incorporated an 80-foot-wide vegetated setback and included a six foot high berm within that area to buffer the neighbors from activities in the park and this berm remains in the design (outlined in magenta below). The entire berm will be constructed in Phase 1. Additionally, along the north side of the Indian Summer neighborhood, between the homes and the park road, the existing dense vegetation and stormwater pond are to remain in place. This buffer ranges from 85′ – 145′ in width.



Regarding security, the park maintenance facility is located at the site and will provide consistent staff "eyes on the park". Also, the Parks department employs three full-time park rangers that work seven days a week to address any

issues. Park Rangers are available to be contacted by the public directly by phone or email. With over 50 parks in the Olympia park system, this has proven an effective approach to ensuring safe and secure parks.

We hope that the above information helps to clarify the items included in your emails. Both the Parks Department and School District are happy to try and answer further questions.
