The applicant also requests a forest land conversion to harvest 0. 92 acres of timber. Additionally, the Applicant seeks two variances from the Thurston County Code (TCC) subdivision standards; 1) A required 30- ft. buffer from adjacent use and to deviate from setback standards, both would affect a limited number of parcels.
