

**2016 MASTER INTERLOCAL AGREEMENT  
BETWEEN CITY OF OLYMPIA AND THURSTON COUNTY  
FOR TRANSPORTATION SERVICES**

**REQUEST FOR SERVICES  
THURSTON COUNTY  
MUD BAY ROAD AND DELPHI ROAD TRAFFIC SIGNAL WORK**

---

**SCOPE OF SERVICES**

The work under this request consists of City of Olympia providing technical support to Thurston County for the traffic signal work at the Mud Bay Road and Delphi Road intersection which is included in the Countywide Safety Upgrades Project (CRP# 61500). Project work will be completed by a Contractor.

**RESPONSIBILITY OF THE COUNTY**

The County shall be responsible for:

Contract administration and construction inspection.

Providing project plan sheets for Mud Bay Road and Delphi Road traffic signal work.

Providing the City with signal timings for controller input.

Authorizing work to begin on agreed upon dates and provide a minimum 24-hour notice to the City for any delay or canceling of scheduled work.

Reimbursement of the City's costs for performance of City's responsibilities, including but not limited to materials, labor, equipment and overhead (25% of labor costs). The estimated cost for these services is approximately \$3,000.00 as described in Attachment "A".

**RESPONSIBILITY OF THE CITY**

The City shall be responsible for:

Providing assistance in reviewing the Contractor's material submittals for traffic signal components.

Providing assistance in answering technical questions from the Contractor before and during construction.

Testing, programming, and inputting timing into the 2070 signal controller. Initial testing will be completed by WSDOT.

Installing the 2070 controller, 2010E conflict monitor and any other hardware necessary in the existing cabinet in order to accommodate the 2070 controller and flashing yellow arrow operations.

## ADMINISTRATION

The following individuals are designated as representatives of the respective parties. The representatives shall be responsible for administration of this Contract and for coordinating and monitoring performance under this Contract. In the event such representatives are changed, the party making the change shall notify the other party.
