Draft Charter Discussion

ACAC Charter development

Adopted by the BOCC in Jan 2022.

Seeking co-sponsors to help with projects. Thoughts or nominations for co-sponsors.

Jennifer - How was the 2022 ACAC adopted?

Lynette – Brought to BoCC to expand this program to encompass more than voting. For example, another county was able to purchase wheelchairs people could use to make the beach accessible.

Jennifer – was the charted adopted through resolution or ordinance?

DB – A letter was sent to the gov allowing the county to adopt the ACAC to allow us to invite more members to participate. Not through ordinance. The framework presented in the charter will serve as a guide.

Draft Charter

Committee purpose/motivation

Wanting members from different departments and divisions to help the ACAC achieve more.

Jennifer – Is the idea that we would list out new members or would membership be more fluid.

Lynette – May need specific names or have a primary/backup from each division.

DB – want to go through some of the specifics so people know what is being discussed, what we are trying to accomplish, and future meetings.

Jo'el - DVR is a part of the dept of Health and Human Services. My specialty is accommodation. Works in Division 3 which encompasses the Olympic Peninsula to Vancouver.

Robin – Would be helpful to go over objectives. Can help to inform who in the county would participate.

Lynnette – Forum objectives from draft.

Jennifer – Maybe we could have some more specificity, the RCWs lay out specific activities.

Lynnette – we can take the language out of the RCW's to add to the ACAC objectives.

DB – Those guidelines were in the original letter drafted by Commissioner Mejia and we can add them back into the draft.

Activities and Outputs

Meet as a group 3-4 times a year and could add more when there are ongoing projects.

Feb, May, and Sept identified as possible months for meetings

Current resources – BoCC assurances letter to Gov office, Accessible voting plan, Membership base made up of former VAAC members.

DB - does anyone have any concerns on these placeholder items?

Jo'el - Under continuously inform office and dept officials about accessibility issues – what happens to those concerns?

DB – We would be gathering any feedback/concerns form group and escalate items based on the issue presented. These items will be discussed in this forum. Communications person has a comms group and

will be presenting this information to them. Are you talking about ideas for projects to brainstorm or about a specific issue?

Jo'el - Just about bringing concerns about things seen in the community forward.

Robin – Anything that the Advisory committee sends to county departments get taken into consideration by the BoCC with no promise of action.

Jennifer – Gives us an opportunity to look at areas in a more systemic way that will allow us to identify opportunities, small or large, and give a forum to have those discussions and receive communication from community members that are impacted.

Membership

Deadline to let us know if you want to opt out of being a member is Sept 15 to help us move forward with future meetings.

We are working on a possibility of creating an application to help with membership duties.

Jennifer will be present or will send someone in her absence. Jo'el and Craig agree.

Lynnette – will be sending some future dates.

Jennifer – A sentence from the draft to "make a more accessible community for all" seems to be the vision of the ACAC and should be highlighted.

Jamey will work on adding some of these suggestions into the charter and then send it out to the committee for further input before finalizing the charter.

DB - is there something specific that is on a wish list as to why interested in being a member of this group?

Craig – With the example with the wheelchairs earlier, is this a group that has the connections to create/find funding/resources to be able to make changes and make the community more accessible?

Holly – agrees with Craig, at the library tends to support organizations to create awareness of where people can go to get resources. Tend to work towards how to get information to people and being a place where people can gather.

Robin – having something that formally reports the work on the group would be beneficial.

Jennifer – Would we be doing agendas and meeting notes/minutes?

DB – Yes, and will need a content library, such as SharePoint, where all can see group content.
