


Updated COVID-19 Testing Recommendations - a Fond Farwell to Dr. Diana Yu and a Warm Welcome to Dr. Dimyana Abdelmalek

Requested Action:

- Test all patients with symptoms consistent with COVID-19 regardless of age or health status and their close contacts even if the contacts are asymptomatic.
- Test all patients with new onset of symptom(s) consistent with COVID-19, regardless of their age or health status. Patients should be tested as soon as possible after seeking care, ideally within 24 hours which is critical to identifying and isolating case, quarantining contacts and reducing community spread. If healthcare providers are unable to provide testing within this timeframe, patients should be referred to another testing site. Test patients with:
 - Cough, or
 - Shortness of breath or difficulty breathing OR at least two of:
 - Fever
 - Chills
 - Repeated shaking with chills
 - Muscle pain
 - Headache
 - Sore throat
 - New loss of taste or smell
- Test youth and young adults, under the age of 18, presenting for care without their parents or guardians under the following circumstances:
 - If they are legally emancipated
 - If they are living homeless
 - If they are considered a * 'Mature Minor'
- * "Mature Minor Doctrine" means that a minor can give consent for testing if the provider deems they are capable of understanding or appreciating the consequences of a medical procedure. In determining whether the patient is a mature minor, providers will evaluate the minor's age, intelligence, maturity, training, experience, economic independence or lack thereof, general conduct as an adult and freedom from the control of parents.
- Direct individuals to self-isolate at home and provide them with the one page guidance document below that best fits their situation pending receipt of test results and direction from Thurston County Public Health and Social Services Department.


