# COVID-19 Testing Recommendations and Laboratory Resources to help with Extended Testing Times Experienced through some Commercial Labs

# Requested Action:

- Test all patients with a new onset of symptoms consistent with COVID-19 regardless of age or health status. Test all close contacts of confirmed cases even if the contacts are asymptomatic. Thurston County Public Health and Social Services will notify close contacts and inform them of need for testing. Contacts may seek testing from their personal providers. A close contact is defined as being within six feet for fifteen minutes or more of a confirmed case starting two days before symptom onset or two days before positive test for asymptomatic confirmed cases.
- Inform all patients of the need to self-isolate or quarantine at time of testing and ensure patient has understanding of quarantine and isolation process. Patients who have a positive test should isolate at home until they have been fever free for 72 hours without antipyretics, symptoms have gotten better and at least ten days have passed since symptom onset. Asymptomatic patients who test positive should isolate at home for 10 days after positive test unless new symptoms appear. Patients with negative test results should quarantine for 14 days.

 Consider using alternative laboratory services to reduce the time between testing and the rapid receipt of test results.

We recently became aware of significant delays in obtaining COVID-19 test results from some large commercial labs. This is very concerning because obtaining test results quickly is critical for informing our case and contact tracing, COVID-19 monitoring efforts and containing the spread of the virus.

In many cases, our in-state laboratories can process specimens and return results more rapidly than out-of-state labs. **We strongly encourage you to use our in-state labs for COVID-19 testing so that we can shorten the turn-around time for test results.** Furthermore, it would be useful for providers to identify multiple laboratory testing options so that COVID-19 specimens can be redirected to other labs in the state when necessary to ensure rapid results for patients.
