

The purpose of the Treatment Sales Tax (TST) Advisory Committee is to make non-binding recommendations to the Thurston County Board of County Commissioners (BoCC) on the use of treatment sales tax funds each year during the budget process. Recommendations are based on the county-wide strategic plans and performance reviews of existing programs. The advisory committee shall be subject to the Open Public Meetings Act, chapter 42.30 RCW.

## **Terms of Office**

Appointments are for two or three-year terms; members may be reappointed.

### **Members**

A maximum of nine advisory committee members.

## **Qualifications of Board Members**

The committee is comprised of residents of Thurston County with an interest in services and programs for Thurston County residents with mental health or substance abuse issues. Members will have no commitment, investment, obligation, or involvement (financial or otherwise), in any agency contracting with, submitting any proposals to, or is expected to submit any proposals to the Treatment Sales Tax Fund. A former committee member may submit proposals to the Treatment Sales Tax fund only following a minimum of one full calendar year after the date of their official departure from the committee.

# Vacancies filled by

Upon a vacancy on the advisory committee, a successor shall be selected and appointed by the BoCC to fill the unexpired term.

### Removal is by

Advisory committee members serve at the pleasure of the BoCC and may be removed by majority vote of the BoCC. If a member of the advisory committee misses two consecutive advisory committee meetings without adequate excuse, the advisory committee may request removal of that member by the BoCC.

## **Member Biographies**

### **Robert Almada**

Robert Almada is a law enforcement professional with over 30 years of experience. He began his law enforcement career with the Santa Monica Police Department in 1990, retiring in 2019 as a Police Captain to accept a position as Deputy Chief of Police for the Lacey Police Department. Robert was appointed as the Interim Chief of Police for the Lacey Police Department in May 2020 and confirmed as Chief of Police in June 2021. Robert's career has given him unique insights into the suffering and successes of persons experiencing intolerance, substance addiction, mental illness, and homelessness.

Robert actively participates on a variety of boards and commissions including serving on the policy board for the Thurston County Regional Action Site for the Advancing Pretrial Policy and Research Initiative (APPR) and the APPR Research-Action Site Racial Equity Roundtable (RRR). He has been involved with several homeless and social justice initiatives to promote healing, equity, and community safety. Robert is a life time learner and has received a Masters of Public Administration, a bachelor's degree in business finance, a post graduate certificate in leadership from the Drucker Institute at Claremont Graduate University, and was a member of the inaugural class of the California Police Chief's Executive Leadership Institute.

#### Sarah DeStasio

Sarah is a person with disabilities who co-founded Capital Homecare Cooperative, a worker-owned caregiving agency, after serving her community as a caregiver for many years. She is currently completing a Masters in Counseling.

Sarah also has a Masters in Public Administration from the Evergreen State College where she focused on human services policy. Sarah completed a placement with Frontiers of Innovation, a multi-agency project focused on how the State of Washington can improve outcomes for children and families.

Sarah is a Democratic Socialist involved in a variety of political/community orgs including the Thurston County Democrats and the South Salish Progressive Alliance. She encourages everyone to educate, agitate and organize around access to behavioral health and substance abuse treatment.

### **Bob Jones**

Bob Jones is Founding President of Thurston County Veterans Services (TCVS), a nonprofit organization supporting Veterans. Bob retired as a Lieutenant Colonel in the US Army, after 22 years of service. He also owns a Defense Contracting new business development consulting firm, responsible for securing several multi-million-dollar Defense Contracts for small manufacturers nation-wide.

Bob has served as President, Chair, Vice President, Vice Chair or Board Member of 12 Nonprofit Business, Social Services, University Alumni or Veterans Organizations over many years. He holds Master of Science and Bachelor of Science degrees from Indiana University.

### Tonia McClanahan

Tonia McClanahan is a contracted Social Service Worker with the Washington State Office of Public Defense Parent Representation Programs and formerly the Parent4Parent Program Director for Thurston, Mason and Lewis Counties. She has been working collaboratively with attorneys, parents, and stakeholders to help parents navigate the Children's Justice Systems and come to a resolution in the Dependency Court process.



Tonia also sits on various committees and boards at local and state levels. She has been mentoring parents in the Dependency process since 2005 and has testified to help support Legislative work to improve child welfare systems since 2006. In 2013 she became the first Birth Parent to sit on the Washington State Supreme Court Commission on Children in Foster Care. Tonia also is a member of Family Recovery Drug Court teams in two counties, State SafeBabies Design Team, a local Executive Dependency Advisory Group, Strophy Foundation, State Background Check Workgroup, and Statewide Reunification Steering Committee. She champions the Protein for All program and Hangry Carts as well as the local Mockingbird Society Chapter.

### **Wendy Tanner**

Wendy Tanner, MSW has spent her career working in human services, including 16 years at Community Youth Services (CYS) where she worked as the Chief Financial Officer/ Chief Operations Officer and 5 years at Valley Cities Behavioral Health as a Clinical Services Director.
