**NOTICE OF PUBLIC HEARING
FOR THE THURSTON COUNTY
PLANNING COMMISSION**

The Thurston County Planning Commission will hold a public hearing on Wednesday, December 1, 2021 at 7:00 p.m., or soon thereafter. The hearing will be held virtually. The Planning Commission will provide a link to connect remotely to the public hearing for those interested in providing testimony one (1) week before the meeting at: <https://www.thurstoncountywa.gov/planning/Pages/pc-meetings.aspx>.

The hearing is to take public testimony on official development code docket item A7, "Low Impact Development (LID) Code Amendment". This is a limited-focus update to portions of the LID codes adopted in 2016 to correct inconsistencies and update regulations that are difficult to implement. The proposed amendments will also include new definitions, updated references, and process improvement changes that will simplify the overall review process for the property owners.

The Planning Commission may make a recommendation to the Board of County Commissioners on the proposal during this time, or at any scheduled meeting thereafter.

Those wishing to testify should connect remotely to the virtual public hearing and be heard. If unable to attend, mailed or emailed comments must be received no later than December 1, 2021 by 4:00 pm.
