SUBJECT: Shoreline Master Program Update – Updated Proposed Timeline

An option was discussed at the last Planning Commission meeting to hold off on submittal of the “redline” version of the draft SMP document until early 2019. Doing so would help prevent a piecemeal review of the “redline” draft document and allow for discussion on the remaining chapters and appendices to occur by the Planning Commission and Regulatory/Small Group. Staff therefore is proposing an updated schedule to remove submittal of redline Chapters 19.100-300 on November 28, 2018 and move submittal to February 2019. Below is a **updated** draft timeline for Planning Commission review of revisions to the Thurston County Shoreline Master Program (SMP) based on comments received from the Planning Commission.
