RE: Superior Court Calendar Changes – Civil Motions, Dispositive Motions and Appeals Calendar; civil case assignment

This memo is provided to remind parties that Thurston County Superior Court Trial Judges are no longer issuing case specific orders for every scheduled hearing on their civil motions, dispositive motions, and Appeals Calendar. Instead, all participants in Friday morning hearings will be expected to appear at 9:00 a.m. and all participants in Friday afternoon hearings will be expected to appear at 1:30 p.m. The judge will determine the order of arguments at the outset of the calendar. Parties, lawyers, and the public may attend hearings using the ZOOM application or in person. Because of the pandemic, the court continues to encourage remote participation if possible. The ZOOM information listed below will allow remote participation in each judge's calendar. This information is also published on the court's website.

Orders Regarding Scheduled Civil Motions in specific cases will take precedence over the general guidance in this memo. If you receive a case-specific order, follow the court's order, which may include appearing in person, or at a special time or not appearing at all if the court indicates it will decide the motion without a hearing.

Even though remote participation is authorized, all courtrooms remain open to the public during every hearing including those in which remote participation is available using Zoom.
