### Civil case calendar information:

\*\* Friday Civil Motions: Main Campus will hear hearing dispositive motion and civil motion calendars on Fridays. The Court has imposed caps on the calendars, and the assigned Civil Judge will determine whether each matter will be heard in person, on Zoom, telephonically, on the pleadings, or whether it may need to be rescheduled to comply with health directives. Calendars will be limited to 12 motions on the Civil Motion Calendar and one motion on the Dispositive Motion Calendar. Friday Motion calendars will not be available for ex parte. (Civil Ex Parte and Emergency Matters process is linked [here](#).)

Friday Civil Motions, Dispositive Hearings, ALRs, and Appeals: Civil motions will only be heard in the following manner to be determined by the trial judge:

- a. without oral argument,
- b. Zoom hearing,
- c. telephonically set time specific by order, or,
- d. continued to a future date to ensure health care directives are followed.

### Criminal case calendar information:

\* 11 a.m. OC Omnibus is designated for panel and private attorneys.

An Omnibus Hearing can be stricken by a Consolidated Omnibus Order (COB) being entered in advance with the following language included “The Omnibus Hearing on \_\_\_\_\_ is hereby stricken.” and marking or writing “Clerk’s Action Required” on the front page in the caption.

I/C COPAS can have a cap of 2 per session if done in person and not by edocs. If done only by edocs, I/C COPAS will likely be 1, every 30-45 minutes. Also, O/C COPAS can be set on I/C COPAS calendars if there is capacity. I/C COPAS cannot be set to O/C COPAS calendars.

Evidentiary = any matter which normally would be scheduled on an Evidentiary Hearing or a Suppression Hearing calendar.

Drug Court Calendars and Staffing: Staffing and Court will be done via Zoom or time specific calendaring if in person.

Any COPAS that will require a longer sentencing or may have a large volume of the public attending (ex. Multiple individuals who would like to speak at the sentencing hearing) – attorneys must contact the criminal case coordinator for date/time to be used on NOH when scheduled by the lawyers.

COPAS Wednesdays allow for attorneys to appear by Zoom. Defendants and calendar deputies must appear in person. Defense Counsel should contact Thurston County Public Defense Office for more information.
