### PROTECTIVE AND RESTRICTIVE COVENANTS FACT SHEET

This guide will help those filling out protective and restrictive covenants. This should be used in conjunction with the attached sample covenants. The “Sections” as noted on the examples, refer to those parts of the covenants that shall be completed. Contact Thurston County Environmental Health Division if you have any questions regarding covenants.

#### WHAT IS A COVENANT?

A covenant is a recorded agreement or restriction prohibiting certain activities or practices near a particular well or spring to protect the water source from potential sources of prevent contamination. The protective area around the water source is referred to as the sanitary control area. The required sanitary control area is a radius of 100 feet for wells, and 200 feet for springs. When filing covenants for a single-family well, you must file as a Non-Public Water Source. Covenants filed for wells to serve public water systems (2-Party, Group B and Group A water systems) must be filed as a Public Water Source.

#### DECLARATION OF COVENANT

When the water supplier owns all or part of the area in the sanitary control area, you should complete a “Declaration of Covenant”. See Example 1 for a completed Declaration of Covenant. How to complete Sections A and B are explained below:

**Section A:** The legal description of the property where the well is located should be filled in here. See Example 1, “Section A”. This should be specific, as shown in the following example:

Lot 2 of short plat number \_\_\_\_\_, recorded in Volume \_\_\_\_\_, Page(s) \_\_\_\_\_, of short plats as recorded in Auditors file number \_\_\_\_\_ in Thurston County, Washington.

Long or complex legal descriptions can be attached on a separate document which shall be filed with the covenant. However, this attachment must be referenced as shown on the example “Attachment A”.

**Section B:** This refers to the precise location of the well on the lot described in Section A. See Example 1, “Section B”. It is acceptable to attach a map that shows the location of the well on the property, rather than to prepare a legal description for the exact well location. The example “Attachment A” shows how this can be done.

#### RESTRICTIVE COVENANT

When someone other than the water supplier owns portions of the sanitary control area, you must obtain a “Restrictive Covenant” from the landowner. See Example 2 for a completed Restrictive Covenant. How to complete Sections C and D are explained below:

**Section C:** This section refers to the property that is granting the restrictive covenant; specifically the property neighboring or adjacent to the parcel where the well is located. The legal description of this parcel should be written or referenced here. See Example 2, “Section C”.

**Section D:** This refers to the property on which the well is actually located. Indicate in this part, **both the description of the property and the well’s location on the property**. See Example 2, “Section D”. Once again, a map is often the best way to show the location of the well as shown on the example “Attachment A”. Again be specific, as shown in the following example:

**NOTE:** Even if a legal description is prepared for the well’s location, a map showing the well should be filed with the covenant.

DECLARATION OF COVENANT

and grantor(s) is (are) required to keep the water supplied from said well free from impurities which might be injurious to the public health.

It is the purpose of these grants and covenants to prevent certain practices hereinafter enumerated in the use of said grantor(s) water supply.

NOW, THEREFORE, the grantor(s) agree(s) and covenant(s) that said grantor(s), his (her) (their) heirs, successors and assigns will not construct, maintain, or suffer to be constructed or maintained upon the said land of the grantor(s) and within 100 (One Hundred) feet of the well herein described, so long as the same is operated to furnish water for public consumption, any potential source of contamination, such as septic tanks and drainfields, sewerlines, underground storage tanks, roads, railroad tracks, vehicles, structures, barns, feed stations, grazing animals, enclosures for maintaining fowl or animal manure, liquid or dry chemical storage, herbicides, insecticides, hazardous waste, or garbage of any kind or description.

These covenants shall run with the land and shall be binding to all parties having or acquiring any right, title, or interest in the land described herein or any part thereof, and shall inure to the benefit of each owner thereof.

which well and waterworks are in close proximity to the land of the grantor(s), and said grantee(s) is (are) required to keep the water supplied from said well free from impurities which might be injurious to the public health.

It is the purpose of these grants and covenants to prevent practices hereinafter enumerated in the use of the said grantor(s) land which might contaminate said water supply.

NOW, THEREFORE, the grantor(s) agree(s) and covenant(s) that said grantee(s), its successors and assigns, said covenants to run with the land for the benefit of the land of the grantee(s), that said grantor(s), his (her) (their) heirs, successors and assigns will not construct, maintain, or suffer to be constructed or maintained upon the said land of the grantor(s) and within 100 (One Hundred) feet of the well herein described, so long as the same is operated to furnish water for public consumption, any potential source of contamination, such as septic tanks and drainfields, sewerlines, underground storage tanks, roads, railroad tracks, vehicles, structures, barns, feed stations, grazing animals, enclosures for maintaining fowl or animal manure, liquid or dry chemical storage, herbicides, insecticides, hazardous waste, or garbage of any kind or description.

These covenants shall run with the land and shall be binding to all parties having or acquiring any right, title, or interest in the land described herein or any part thereof, and shall inure to the benefit of each owner thereof.
