

Statement of 2020 Assessed Values for Property Taxes Collected in 2021

This annual report offers statistics on the 2020 assessed values for property taxes due in 2021. Property assessments are updated annually and are based on fair market value as of January 1. Thurston County’s real estate market for 2020 resulted in an increase in value of \$2.674 billion. New construction increased to \$733 million, \$80 million more than the previous year. Some tax rates changed for the 2021 tax year because of special levies, lid lifts approved by voters, taxing district budgets, and legislative action to the Local School & State School levy (EHB 2242)(ESSB 6614)(2SSB 5313).

Countywide Results of Assessment Year 2020 Revaluation

- Thurston County’s assessed values totaled \$40.681 billion.
- This represents an overall increase of \$2.674 billion from the previous year.
- The percent increase in total assessed value is about 7.0%.

The mission of the Thurston County Assessor's Office is

- ✓ To appraise all property on a fair and equitable basis,
- ✓ To maintain accurate and easily accessible property information, and
- ✓ To provide accurate tax assessments.

Assessment Information:

The County Assessor determines current market value of all property in Thurston County for tax purposes. Levy amounts are based on budgets submitted by taxing districts. Each year all properties are revalued to Fair Market Value with one-sixth of the county being physically inspected. Appraisers use valid sales data and current replacement costs (based on labor and material, less depreciation) to arrive at fair market value. This ensures that each owner pays a proportional share of property taxes that support public services, such as schools, libraries, roads, fire, police, and emergency services.

Search by street number, name, or both; select sort order from drop box located near the bottom of the page followed by the submit button, select the property you are inquiring about by clicking on the property number in the far-right column under Normal View, then view details by clicking on the category tabs listed at the top of the page

The Board of Equalization is an independent body whose members are appointed by the Thurston County Board of Commissioners to determine questions of value. They accept appeal petitions, schedule hearings and issue appeal decisions.



HOW TAX RATES ARE DETERMINED

Tax rates are expressed in dollars per thousand dollars of assessed value. The budget needs of various taxing districts influence tax rates. After districts approve their budgets and voters pass or defeat special levies, the schools, cities, fire districts, the county, the library, the port, roads and other special districts submit their budgets to the county.

Toward the end of the calendar year, the Assessor can then calculate tax rates for each district and each tax code area. The tax rate for the individual taxing district is determined by dividing the approved district budget by the taxable assessed value of property within its district boundaries. Many rates changed for 2021 due to voted levies, lid lifts, and legislative action (EHB 2242)(ESSB 6614)(2SSB 5313).

Example of Taxing District Tax Rate:

$$\frac{\text{City of Olympia Levy Amount } \$19,586,339.74}{\text{Olympia's Assessed Values } \$8,046,605,908} = \$2.4341 \text{ Tax Rate}/\$1,000$$

An aggregate tax rate is calculated for 75 specific regions in Thurston County known as Tax Code Areas (TCAs). The TCAs are a unique combination of taxing districts that overlap to provide services to property owners in each area.

The aggregate tax rate is determined by totaling the individual tax district rates of the districts that provide service for each area. For example, TCA 110 is located in the City of Olympia. It consists of 9 different taxing districts and has an aggregate tax rate of \$12.89 per \$1,000 of assessed value for 2021 property taxes.

Tax rates over time generally decline as assessed values increase. Since 2007, the average property tax rate countywide has **increased** \$1.15 or 10% as shown below.

In 2017, the legislature enacted EHB 2242 in order to address the Supreme Courts' ruling in the McCleary/School funding case. This legislation made some significant changes to the local and state school levies. In 2018, the legislature enacted ESSB 6614 which reduced the State School levy to a rate of \$2.40 per thousand market value for the 2019 tax year only. For the 2020 tax year it will return to \$2.70 per thousand market value. In 2019, the legislature enacted 2SSB 5313 which increased school district enrichment levies from a maximum \$1.50 per \$1,000 rate to \$2.50 per \$1,000 rate unless the levy is limited by the voter approved amount or the maximum per-pupil limit. The following chart details the accumulative effect of these changes by district for 2021 tax year collection.

EXAMPLE: The owner of a home valued at \$250,000 in the Centralia school district will see a decrease in their state and local school taxes of (250 X 1.3763) \$344.07.
