Statement of 2021 Assessed Values for Property Taxes Collected in 2022

This annual report offers statistics on the 2021 assessed values for property taxes due in 2022. Property assessments are updated annually and are based on fair market value as of January 1. Thurston County’s real estate market for 2021 resulted in an increase in value of \$6.594 billion. New construction slightly decreased to \$729 million, \$4 million less than the previous year. Some tax rates changed for the 2022 tax year because of special levies, lid lifts approved by voters, taxing district budgets, and legislative action to the Local School & State School levy (EHB 2242)(ESSB 6614)(2SSB 5313).

Countywide Results of Assessment Year 2021 Revaluation

- Thurston County’s assessed values totaled \$47.275 billion.
- This represents an overall increase of \$6.594 billion from the previous year.
- The percent increase in total assessed value is approximately 16.2%.

Assessment Information:

The County Assessor determines current market value of all property in Thurston County for tax purposes. Levy amounts are based on budgets submitted by taxing districts. Each year all properties are revalued to Fair Market Value with one-sixth of the county being physically inspected. Appraisers use valid sales data and current replacement costs (based on labor and material, less depreciation) to arrive at fair market value. This ensures that each owner pays a proportional share of property taxes that support public services, such as schools, libraries, roads, fire, police, and emergency services.



HOW TAX RATES ARE DETERMINED

Tax rates are expressed in dollars per thousand dollars of assessed value. The budget needs of various taxing districts influence tax rates. After districts approve their budgets and voters pass or defeat special levies, the schools, cities, fire districts, the County, Timberland Library, the Port, road's and other special districts submit their budgets to the County.

Toward the end of the calendar year, the Assessor can then calculate tax rates for each district and each tax code area. The tax rate for the individual taxing district is determined by dividing the approved district budget by the taxable assessed value of property within its district boundaries. **Many rates changed for 2022 due to voted levies, lid lifts, and legislative action (EHB 2242)(ESSB 6614)(2SSB 5313).**

Example of Taxing District Tax Rate:

$$\frac{\text{City of Lacey Levy Amount } \$8,046,612.00}{\text{Lacey's Assessed Values } \$9,132,866,690} = \$0.8811 \text{ Tax Rate}/\$1,000$$

An aggregate tax rate is calculated for 73 specific regions in Thurston County known as Tax Code Areas (TCAs). The TCAs are a unique combination of taxing districts that overlap to provide services to property owners in each area.

The aggregate tax rate is determined by totaling the individual tax district rates of the districts that provide service for each area. For example, TCA 241 is located in the City of Lacey. It consists of 9 different taxing districts and has an aggregate tax rate of \$11.61 per \$1,000 of assessed value for 2022 property taxes.

What has been happening to tax rates over time?

Tax rates over time generally decline as assessed values increase. Since 2008, the average property tax rate countywide has **increased** \$1.60 or 16.4% as shown below.

Comparison of School District Levy Rates from 2021 to 2022

In 2017, the legislature enacted EHB 2242 to address the Supreme Courts' ruling in the McCleary/School funding case. This legislation made some significant changes to the local and state school levies. In 2018, the legislature enacted ESSB 6614 which reduced the State School levy to a rate of \$2.40 per thousand market value for the 2019 tax year only. For the 2020 tax year it returned to \$2.70 per thousand market value. In 2019, the legislature enacted 2SSB 5313 which increased school district enrichment levies from a maximum \$1.50 per \$1,000 rate to \$2.50 per \$1,000 rate unless the levy is limited by the voter approved amount or the maximum per-pupil limit. For tax year 2022, the state school levy returns to a budget based levy. The following chart details the accumulative effect of these changes by district for 2022 tax year collection.
